<u>Marina</u>: No report. Last month we approved the purchase of LED lights for the flag pole, but we didn't have an estimate on the installation yet. <u>Parks and Rec</u>: Just generally following up with on going plans. There is an approval of preliminary plans for Nichols Point Park farther down on the agenda.

<u>Planning</u>: Met last week. Continuing zoning reviews and there is a Public Hearing scheduled for 10/22 on the land use request for the school.

<u>Transfer Station:</u> Slow. Everything is good. Probably going to have to delay the concrete work until next year. Cut off for large items will be Nov 15<sup>th</sup> in anticipation of the last pick-up for the year.

**Zoning:** Applications are slowing some. We received 2 new ones yesterday. The new ArcGIS is on line and Damien is familiarizing himself with its usage. It will be a great tool to assist planning, zoning and many areas of the township.

# **Old Business:**

**RE-zoning application Liedel:** An application to rezone parcel 001-034-015-60 to Commercial 2 was submitted to the planning commission in April of 2024. On 6/27/24 there was a public hearing on the request and on 7/24/24 the PC voted to recommend to the board that the zoning request be denied. Notification has to go to Mackinac County Planning prior to the township board's final decision. Mackinac County has to be given 30 days to respond. The Bois Blanc Township review was tabled in September to await a full board. Prior to this evening's board meeting a variety of documents were supplied to each board member including: a download of all current commercial property on BBI with a corresponding map of their locations, the planning commission's summary and final recommendation supplied by the zoning administrator, a summary of all letters received by the planning commission and the minutes from the 6/27/24 public hearing, a letter from the township attorney regarding regular rezoning vs conditional rezoning, and additional letters and petitions received since the planning commission meeting in July. Motion was made by D Akright, 2<sup>nd</sup> by A Kennedy to open for discussion the rezoning request. There was great discussion among board members and those in attendance. A summary was given of the PC determinations and a review of topics of concern pointed to in letters were addressed. Motion was made by A Kennedy, 2<sup>nd</sup> by D Akright to grant the rezone requested from residential to commercial 2. Roll Call vote: Ayes: A Kennedy, D Akright Nays: T Wybranowski, B Sharpe, K Viers **Motion 2024-125** Request to Rezone was **denied.** 

\*It should be noted that there is great appreciation for those serving on the Planning Commission and desire to do what is best for the Township as a whole as well as Jeff Liedel's willingness and cooperation to utilize the system that is in place within our zoning rules and regulations for review further set the determination of land use. All showed a great respect for the process. There were many in the meeting that supported both sides of the issue and all construction discussion was appreciated.

### **Public Comment:**

- Jim Blamer suggested that we might want to make a deal with the DNR for some land to be a light industrial park where storage units could be put in as the Wildlife Assoc also needs a place to store feed.
- Jim Blamer had questions about the parking at the Marina and wasn't happy about his 2<sup>nd</sup> parking place costing \$100 rather than \$60.

### **New Business:**

Request for burial rights was submitted for Bob & Martha Stowe. Motion was made by D Akright, 2<sup>nd</sup> by K Viers to approve burial rights for Block 7, Lot D, plots 4&5. Roll call vote: Ayes: A Kennedy, B Sharpe, D Akright, T Wybranowski, K Viers Nays: none Motion 2024-126 carried

Clerk will provide for him a copy of the overall budget for the township so he has a better idea of where his tax dollars are budgeted to be spent. An explanation of how the request for Parks & Rec millage came about and what in general the funds would be for was given. Dale asked how much it cost to put a proposal on the ballot. Actually, the only cost is the legal fees required to have the wording prepared to meet all necessary laws. As long as the proposal goes before the people during a normal election year and is not a "special election", there are no additional charges that the township does not already have to incur.
